The Employee understands and agrees to the following: 1.) this Salary Reduction Agreement is legally binding and irrevocable with respect to all amounts earned while this agreement is in effect; 2.) this Salary Reduction Agreement may be terminated at any time for amounts not yet earned, and that a termination request is permanent and remains in effect until a new Salary Reduction Agreement is submitted; 3.) this Salary Reduction Agreement may be changed with respect to salary not yet earned in accordance with Employer's administrative procedures; 4.) Employee is responsible for determining that the salary reduction amount does not exceed the amount permitted to be contributed in that year in accordance with the limits of the Internal Revenue Code. The Employer agrees to provide to the Employee, upon request, any available information from the Employer's records which is necessary to enable the Employee to make these determinations. The Employee acknowledges and agrees that the Employer has no responsibility or obligation under this agreement except payment of the aforementioned contributions. The Employee hereby releases the Employer from any and all other liability.
